

Guest Application for TJHSST Prom: Sat., April 22nd at The Sunset Room from 8pm to 11pm

YOUR SIGNATURE BELOW MEANS YOU AGREE TO ABIDE BY ALL FCPS AND TJHSST RULES AND GUIDELINES.

- Only one (1) non-TJHSST guest is permitted per TJHSST student. Guest tickets are \$50.00 payable via MySchoolBucks.
- Students must enter the dance no later than 10pm and leave with their guests. Once you have entered the dance, you may not exit and reenter. Students must be picked up from the dance no later than 11pm.
- Guests must show ID for admission to the dance. A list of guests will be maintained at the dance check-in for verification. No guests will be admitted unless their name is on the official guest list.
- You must have all fees/fines paid and be in good disciplinary standing for admittance.
- Each application is verified for accuracy. In the event of any forged signature(s), both the TJHSST student and the guest will be denied admission.
- TJHSST students are responsible for the behavior & demeanor of their guests as well as for informing their guests of the school's dress code & behavior rules.
- Any person denied entry or removed from the dance by TJHSST is not entitled to a refund.
- Absolutely no use or any possession of alcohol and drugs is allowed at the dance. TJHSST's discipline policies will be enforced otherwise.
- Anyone who appears to be under the influence of alcohol or drugs can be tested by law authorities. If they do not pass this test, parents will be notified, and they will be subsequently removed from the dance with appropriate disciplinary consequences.
- Guests at the TJHSST dance may not be in middle school, regardless of age, and may not be over the age of 20.
- Guests must be approved by their current school's Administration.
